

### Mary Clarkson - Caring for America






#### **Apple Cake by Deanna Rademachir**

4 cups unpeeled apples, chopped and cored  
3 eggs, beaten  
1 cup oil (canola is best)  
2 cups all-purpose flour  
2 cups sugar  
1 teaspoon salt  
1 ½ teaspoon baking soda  
1 teaspoon cinnamon  
Cinnamon and sugar

Combine the apples, eggs and oil in a mixing bowl. In another bowl combine the flour, sugar, salt, baking soda and cinnamon. Stir the flour mixture into the apples, mixing well. Oil a sheet or tube pan thoroughly. Coat the pan completely with the Cinnamon-sugar mixture (2 TBSP works best). Pour the batter into the pan. Bake in a 350-degree oven for 60 minutes.

# ELECTION INTEGRITY

## Texas Senator Bob Hall Proposes Election Integrity Bill at 88th Texas Legislative Session

On Tuesday, Jan. 24, Texas State Senator Bob Hall proposed a new Election Integrity Bill. The bill is currently being drafted in the Legislative Council during the state's 88th legislative session. Senator Hall also hosted an open forum that included election integrity experts and over 300 citizens from all over Texas. The session included presentations from national election integrity experts as well as citizens from counties in Texas that have been on the forefront of election integrity within our state. The reforms included in this Bill will give members of the GOP majority a chance to prove to voters that they are serious about election integrity. Senator Hall says Texans are being asked to believe that the current election system works "because the government says it works"—an assurance he insists is not good enough.

### **Need for Transparency**

Senator Hall described the state's current voting system as a "black box process" that cannot produce sufficient evidence in a court of law to prove that a declared winner, Republican or Democrat, was the choice of most of the voters in any given election. According to Hall, the current Texas voting system is so "opaque" that "neither the voters nor the election workers are privy to what happens inside the 'black box' election process and equipment."

### **Computerization to Blame**

Senator Hall blames computerization for the decline in transparency, accuracy, and accountability of recent Texas elections. Hall said he believes the current election system "sacrifices security for convenience." With good intentions, computers were viewed as the solution to the proverbial ballot box stuffing that has tainted the outcome of Texas elections for generations, Hall said. Unfortunately, that has not been the case. Computers and software have increased the opportunities and frequency of error and fraud in ways never considered and to a level much greater and more difficult to detect. "Our elections are too important not to have a system that delivers a high degree of confidence that the will of the people is being respected," he said.

### **What the Reforms Will Do**

A centerpiece of Hall's proposed reforms is a return to the use of hand-marked paper ballots, sequentially numbered for each precinct, and managed with strict chain of custody requirements. Ballots would be printed on special, secure paper, and the count preserved on a write-once optical disc. Election night audits would be required as result tapes move from precincts to the county and then from the county to the state. This would allow for verification that county totals are consistent with precinct totals, a safeguard Hall says is lacking in the current system. The proposed legislation would require that transmission of results from the counties to the state be over secure one-way lines.

The reform package also includes a tightening of the eligibility requirements for voting absentee. “Mail-in voting encompasses more people than necessary and is too susceptible to abuse and error,” said Hall. Also, immediately before the polls open, the reforms would require a tape to be produced showing there are zero votes recorded in the tabulator; and a result tape must be run and preserved immediately after the polls close. The tabulators are to have limited functions and must not be connectible to Wi-Fi or Bluetooth. They must include secure ballot storage, and the scanners must not be capable of reading the same ballot more than once. The proposed reforms would eliminate electronic poll books, replacing them with paper poll books printed 30 days before in-person voting begins. Curbside voting would be limited to the legitimately disabled, and voters may vote only in their designated home precinct—no more county-wide voting. Withdrawing Texas from membership in the Election Registration Information Center (ERIC) is another proposed reform.

## Opposition Expected

Opposition is expected from both sides of the aisle in the legislature and from individuals at the local level who want to maintain the status quo.

In a **two minute video**, Sen. Hall (District 2) details the fundamental flaws in Texas elections and briefly explains the goals of his new bill proposal.

# LEGISLATIVE UPDATE

The 88th Texas Legislature kicked off on January 10th and will end on May 29th. Several bills have been filed on many meaningful subjects including implementing tighter election security measures, protecting the Border, banning the gender modification of children, prohibiting the use of filthy books in our schools, defending gun rights, protecting parental rights and education freedom, prohibiting taxpayer lobbying, saving women's sports, protecting medical freedom and vaccine choice, in addition to property tax relief. The bill filing deadline was March 10th with a total of 9,114 bills filed by members of the Texas House and Senate.

We want to say a special thank you for your advocacy in banning Democrat chairs early on in session. We took steps in the right direction and hope for an even better outcome next session. Speaker Dade Phelan did reduce the number of Democrat chairs from fourteen to nine in the House and Lieutenant Governor Dan Patrick in the Senate now has only one Democrat chair, who will be retiring this year. Lt. Gov Patrick has pledged to replace him with a Republican, leaving the Senate with only Republican chairs. Sadly, we have not only a Democrat chair, but also a Democrat majority on the Business and Industry and the Corrections Committee in the Texas House. There is no excuse for this from House leadership when Republicans are in the majority.

This past week was busy in the Senate State Affairs Committee, especially on the subject of elections! **Senate Bill 2 by Senator Bryan Hughes** returns the penalty for illegal voting to a second-degree felony, its historic level, and undoes the change from 2021 which lowered it to a misdemeanor. SB 2 later passed the Senate and will now go over to the House for a committee hearing. Additionally, **Senate Bill 921 by Senator Bryan Hughes** was heard and passed out of the State Affairs Committee which bans ranked choice voting in Texas. Most recently, there has been a national push to bring this to Texas. In this confusing system, winners are declared with less than 50% of the total ballots cast. Thankfully Senator Hughes is leading the way with making it clear these types of elections are statutorily prohibited in our State.

Other massively important topics heard in Senate State Affairs this week included banning child mutilation, ending the public funding of gender related surgeries and prohibiting the change of a minor's sex on a birth certificate. These bills included **SB 14** by our own Senator Donna Campbell, **SB 162** by Senator Charles Perry, **SB 250** by Senator Hall, **SB 959** by Senator Campbell, and **SB 1029** by Senator Bob Hall. All of these bills were left pending in committee and are expected to be passed out of State Affairs next week.

**SB 15** by Senator Mays Middleton which puts in place protections for women's collegiate sports, cleared a major hurdle on Thursday, and passed out of Senate State Affairs adding to the protections for K-12 passed last session. **SB 175** also passed out of State Affairs by Senator Mays Middleton which bans taxpayer funded lobbying, a subject which has had repeat attention over the last several years with little traction on the House side. Hopefully this year it will finally get to the Governor's desk.

# LEGISLATIVE UPDATE

[\*\*Senate Bill 3\*\*](#) and [\*\*Senate Bill 4\*\*](#) authored by Senator Paul Bettencourt passed out of the Senate Finance Committee and are now headed to the Senate Floor. These bills together allocate \$16.5 billion in property tax relief. SB 3 specifically increases the Homestead Exemption to \$70,000 for everyone under 65 and \$100,000 for those 65 and older.

[\*\*Senate Bill 645\*\*](#) by Joan Huffman also passed out of committee to go to the full Senate Floor. This bill allows prosecutors to charge people who make, sell and deliver fentanyl with murder and increases the penalty for making or delivering less than one gram of fentanyl from a state jail felony to a third-degree felony. School choice is a topic of extreme urgency by many of our legislators this session. [\*\*Senate Bill 8\*\*](#) and [\*\*Senate Bill 176\*\*](#) will be heard in the Senate Committee on Education on Wednesday, March 22. In other education news [\*\*HB 900\*\*](#) which bans sexually explicit books in public schools will be heard in the House Public Education Committee on Tuesday, March 21st.

On Monday, March 20th, three medical freedom bills will be heard in the Public Health Committee. [\*\*HB 1313\*\*](#) relating to a study on the effectiveness of vaccines against the COVID-19 vaccination and its variants, [\*\*HB 44\*\*](#) which prevents vaccine discrimination against Medicaid recipients, and [\*\*HB 81\*\*](#) relating to informed consent with the COVID-19 vaccination.

Several bills we are looking forward to passing which have yet to receive a hearing include [\*\*Senate Bill 1070\*\*](#) by Senator Bryan Hughes and [\*\*HB 2809\*\*](#) by Jacey Jetton as the House companion which prevent the collection of data outside of the original framework of the Texas Interstate Crosscheck Program, a program created to address duplicate voters in our voter registration system across state lines. [\*\*SB 399\*\*](#) by Senator Bob Hall is a similar bill which requires outright withdrawal from ERIC. Other election bills we are highly interested in include [\*\*SB 512\*\*](#) which prohibits the use of electronic poll books, [\*\*SB 397\*\*](#) which requires printing results tapes, [\*\*SB 2464\*\*](#) which closes the gap from early voting to election day and [\*\*SB 1643\*\*](#) which deals with verification of precinct returns with the canvassing authority. These bills are all authored by Senator Bob Hall, who has done an excellent job working with the grassroots and holding a public discussion with ongoing concerns as to our elections. Also under the elections umbrella is [\*\*HB 2890\*\*](#) by Carrie Isaac which prohibits polling locations at universities of higher education due to public safety concerns. Ultimately, Senate Bill 1 was a good start last session on election reform, but there clearly is more work to be done.

Lastly, [\*\*SB 16\*\*](#) by Senator Hughes bans critical race theory in higher education and [\*\*SB 17\*\*](#) by Senator Brandon Creighton bans diversity, equity, and inclusion (DEI) policies in higher education. The Grid and Border remain priorities, though the Legislature has not had any hearings on these issues yet. [\*\*SB 330\*\*](#) goes a long way to protect Texas' grid from external spy threats--this is particularly important given the most recent Chinese balloon stories! Related to security concerns, [\*\*SB 147\*\*](#) prohibits the purchase of property by foreign entities, but was left pending in committee.
