

A RESOLUTION CONDEMNING THE IMPEACHEMENT OF ATTORNEY GENERAL KEN PAXTON

28 August 2023

Whereas the Texas House of Representatives voted to impeach Ken Paxton and submitted a resolution recommending impeachment. The Hays County Republican Party find the process of seeking an impeachment non-transparent, void of precedence in impeachment procedure, failed to meet the standard of due process and due diligence and ignored precedence in past impeachment procedure.

Whereas outside the knowledge of the rank-and-file members of the Texas House, the General Investigations committee hired a group of partisan investigators and used second and third hand testimony gathered by this hired group, and

Whereas the committee nor any other member of the Texas had an opportunity to question a single $1_{\rm st}$ hand witness, and

Whereas there is no evidence any witnesses were under oath as required under Texas Government code 301.022, and

Whereas Ken Paxton was given no opportunity to speak to the committee or the House nor an opportunity to present evidence, and

Whereas the Texas Supreme court has ruled in Reeves vs State of Texas code 665.081 means offenses used for impeachment must be after reelection not just after original election; therefore, many of the accusations in the resolution must be removed from impeachment consideration, and

Whereas elected legislators are sworn to uphold the laws of the State of Texas, to preserve, protect, and defend the US and Texas Constitutions,

Senator Donna Campbell, MD Statement on the Impeachment Trial of Ken Paxton

In May of 2023 we, the Senate, received articles of impeachment for Attorney Gen. Ken Paxton. The Senate is required to accept the articles. An impeachment is a <u>political trial</u>, not a criminal or civil trial.

Proverbs 18:17, says "The first to present his case seems right, till another comes forward to question him."

We value innocence until proven guilty, it is our right, but the house impeachment process moved like a criminal trial but with a presumption of guilt and suspicion.

The house impeachment process DID NOT follow precedence of previous impeachment trials (see Rep Smithee link - <u>https://www.youtube.com/watch?v=NwzPWa5Xxm4</u>). We will never know if the impeachment would have stopped on the house floor if precedence was followed.

The "burden of proof" for the articles of impeachment rested squarely on the shoulders of the prosecution, and each article had to be proven IN COURT. The bar of evidence used by the prosecution relied on "Good Faith Beliefs," which means, what the witness believes occurred.

Opportunities to confuse opinion, as fact, were seized upon. The prosecution left the door open to speculation and assumptions. There are questions that remain unanswered and only time will lell. The burden of proof rested on the prosecution. I believe the great prosecutors failed to prove any article beyond reasonable doubt and in addition, the articles did not rise to the level of removal from office.

In the 15th – 18th centuries, women were called witches on "good faith belief", executed, then their bodies burned for all to see.

9/16/23 Attorney General Ken Paxton was acquitted by us the Senate, on all 16 articles taken up by the Senate. We also voted to dismiss 4 articles we did not take up.

This was a historical event and I'm glad the right of innocent until proven guilty prevailed.

WHEREAS, Texas House Speaker Matthew McDade "Dade" Phelan voted for the impachment of Attorney General Warren Kenneth Patton, Jr., and through his leadership team pressured dher House members to vole for the impachment as well, and Speaker Phelan continuus to defend this action despite the weaknesses of the cate, which were demonstrated in the Senate trial that resulted in Attorney General Paston's acquitte; and

WHEREAS, Speaker Dade Phelan appointed nine Democrats to chair important legislative committees, in direct defiance of the wishes of Republican voters and the Legislative Priorities of the Republican Party of Texas; and

WHEREAS, Speaker Dade Phelan ignored or actively undermined several GOP priorities during the regular session and failed to advance salient legislation to secure our borders and our elections; and

LT. GOV. DAN PATRICK: LETTER TO STATE AUDITOR

September 18, 2023

AUSTIN – Today, Lt. Gov. Dan Patrick sent an official request to the state auditor to report all expenses from the Texas House of Representatives and Senate related to the impeachment trial of Warren Kenneth Paxton, Jr. Here is the letter that Lt. Gov. Patrick sent:

Ms. Lisa R. Collier State Auditor Texas State Auditor's Office Robert E. Johnson Building 1501 N. Congress Avenue Austin, Texas 78701

Dear Ms. Collier:

As Lt. Governor, I request that the State Auditor's office immediately begin a special audit, pursuant to Government Code Section 321.0135, to determine the total amount of financial expenditures, encumbrances and future unpaid obligations by the Texas House of Representatives, the Texas Senate, and all other legislative entities receiving appropriations through Article X of the State General Appropriations Act, and the Office of the Attorney General, for the time period beginning March 1, 2023 to conclude October 15, 2023.

To be clear, the goal is to determine the absolute total cost to the state of preparing for and conducting this trial from the beginning through its conclusion. This must detail all expenses, including but not limited to, investigators expenses, document production and assembly, attorney expenses, witness fees, travel, food and lodging. This list is illustrative, not exhaustive. Please determine and report on all expenses; if there are invoices outstanding, we seek to know what they are and when they will be received.

Upon completion of your work, I ask that in addition to those entitled to receive State Auditor Reports under Government Code 321.014, that you provide a report to each member of the legislature. I also ask that you prioritize this work so that this special audit may be completed and distributed as soon as possible.

EDITORIAL: SOCIAL MEDIA--LOVE IT OR HATE IT; IT IS HERE TO STAY BY PAMELA EAKIN

Entering into the 2024 Election Year, it is time we move the needle Red with Social Media. It is more important than ever for conservatives in Hays County to internet effectively, use the especially social media platforms. Working together we can and will get Republicans voted back into office in 2024, that is our goal. The Democrats provided us with a plethora of examples on how they use social media effectively, going back to how Obama won with Facebook in 2008 and Trump with Twitter in 2016. We must pay attention to the power of social effective media. This communication is inexpensive and effective, as most social media platforms are free. Money can be added for advertising when it is needed.

Hays County 2022 Election Data showed that we severely lost the 18-40 year old voters. With this said, "if you want to hunt ducks, go where the ducks are." The demographic age group of 18-40 primarily get their news from social media platforms. Some rarely go to their mailbox but they use their phone. Social Media platforms engage more than 2 billion users. Utilizing the Social Media platforms are not a choice; we will not win in 2024 unless we are effectively using them. Steven Rowe from Leadership Institute states that in the past

War Chests were the Big predictor of who had the best chance to win an election. Now, it's not the War Chest but how effectively social media is used to aet voters to the polls. persuade voters and GOP the communicate message. Winners in today's political climate must adapt quickly. Have we adapted to this change? Are we using our social media platforms correctly? What can we do better?

We POST must **CONSISTENTLY.** If our goal is to increase new followers on Twitter, it takes 12-15 tweets per day to build 1,000 new followers in 3 months. A good example is Travis County GOP, they have +5,500 followers. They started tweeting 3 times a day last year; morning, and late noon afternoon, where each tweet included 2 to 3 posts. What a They success! are gaining keeping followers and their followers engaged. This one example shows that we must move beyond posting only about events and holidays once a week. We need to continue posting this but add a little spice, interest, laughter and at times controversy to our posts.

We should target the big three: Facebook, Instagram and Twitter. There are other places we might move into in the future, but for now these are getting the most traffic.

We must ENGAGE our voters on our platforms--Curiosity often will get the click. Take a look at the likes and comments on the We the platform. want banter; it means we have captured our follower's attention. Are our followers information? sharing the Actively encourage it. We must be prepared to accept negative comments;

we just move on. Successful platforms will gain new In addition followers. to building a broad base. we watch the statistics. For example, check the open rate of e-mails. HCRW is proud of their 56% open rate on email communications (where the national average is around 27%). We need to work to keep that great open rate. Surveys are another way we can engage voters. Remember people like to talk, vent, and voice opinions-this is a positive thing. We want to hear their voices.

<u>Leadership Institute Training Link</u>

Web Sites and Posts must be EFFECTIVE. Our webpages should clearly state our message, goal as well as any benefits. This should be highlighted on the banner and the first page. It. should be clear what our goal and benefits are for voting Republican. Look at the effectiveness of the competition we face in Havs County, the Democrat webpage. They have a slick use of web design plus they have a tab at the top that takes one immediately to the Spanish version. Look for All areas of improvement. published webpages should be kept up-to-date. An out-of-date web page does more harm than good, there must be trust in information obtained from а reliable site. First impressions mean everything. The webpage "look" is extremely important. A modern, current look will capture the 18-40 year old voters. Attend to the photos and make sure they represent our large voter base. Be careful about asking for money, don't make the ask the main focus. That's an immediate turnoff for users trying to get voting information. Determine when it is time to in webpage bring designers for а professional approach. Take a close look at the graphics your group is creating. Are they readable, current, eyecatching and youthful?

Ask for other's feedback before publication, extra eyes are a plus. Long, lengthy narratives are not usually read. One great thing to focus on is writing your headline and subject lines. This will increase your e-mail open rate and get attention on important information on the website. What will make а person click to open your email? Capture their attention and interest. There are tools available to help such as CANVA coschedule.com headlines.sharethrough.com to build effective graphics or analyze your headline.

In my opinion, we have a lot to do in Hays County before the 2024 Elections. How do we get started improving our Social Media? First, get educated on what's available and how it's used. Leadership Institute has many online workshops that are free or inexpensive which offer a of information from range Linked-In, Canva, Instagram, Social Media Bootcamp to just name a few. Secondly, develop a plan and goal on how to social accomplish media outreach. Stick to it. Maybe it's time to invest money in a social media management APP, such as MavSocial or HootSuite and hire web designers. We must move forward on Social Media.

As Einstein said, "The definition of insanity is doing the same thing over and over and expecting different results." It is time to change and get a Red Hays County! We can do it!

A young boy from a wealthy Portuguese family is kidnapped and taken to north America in the mid-18th century. He grows to a towering height and becomes known by General George Washington as the Hercules of the Revolution for his heroic deeds and unwavering loyalty to the ideals embodied in our Declaration of Independence and Constitution.

This historical figure is Pedro Francisco, Americanized to Peter Francisco. And because he was Portuguese, he also found himself with the nickname Luso.
